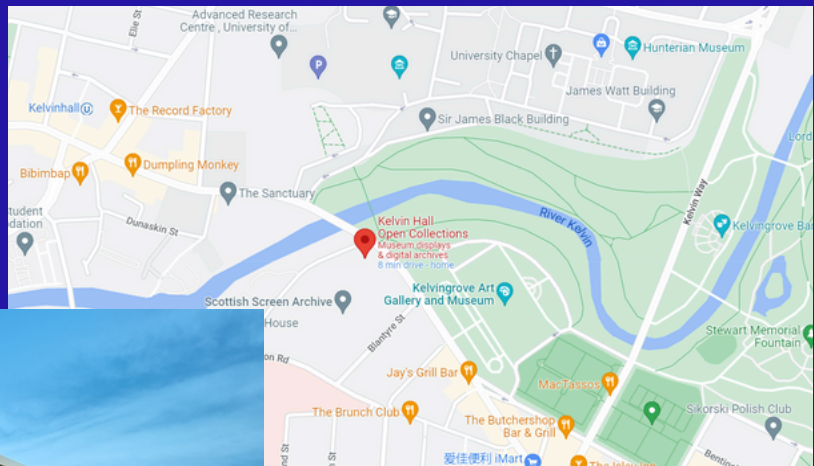

LABOUR MARKET MYTHS

“Everyone has a degree nowadays.”

Yes. Because of the effects of the pandemic on the economy, the proportion of the workforce with a degree is likely to go up. But less than half of students currently aged 14-18 will ever go to university, and it's unlikely we'll ever see a situation where even half of a given age group goes to university. So, your degree has strong currency.

“There aren't any jobs for graduates.”

APS data shows that the UK added 520,300 new professional level jobs in 2019 and we have seen that graduate level positions have (mostly) been far more resilient to the pandemic than non-graduate.

“Graduates only work for big business.”

Each year, 30-40% of graduates go to work for companies with fewer than 250 employees, and one in six were with companies with fewer than 50 employees. SMEs were key in the arts, design, architecture, marketing/PR/advertising, sport/fitness, law and web design.

“If I study (subject), then I will have to do that as a career.”

The UK has a particularly flexible skilled jobs market and the majority of jobs for graduates do not specify a degree discipline, and you can get them with any subject, from fine art to physics. Degrees are designed to teach a wide range of skills and subject knowledge which employers understand.

WORK IN THE UK AFTER STUDIES

If you're an international student or graduate, you may wish to work in the UK after your studies. There are various ways and requirements to secure the right to work here.
